By 'information', we mean personal information about you that we collect, use, share and store.

What we collect

your name;

administer our site and for internal operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes;

Legal basis for processing

Our processing of your personal information is necessary:

About any processing of special categories of personal data, we will rely on obtaining specific consent from you at the time unless there is otherwise a legal requirement for us to process such information.

to provide requested services; and for our marketing and research.

Sharing your information

Except as expressly set out in this policy we will not sell, distribute or lease your personal information to third parties unless we have your permission or are required by law to do so.

The personal information you provide to us may be shared with third party companies, agents, contractors, service providers or affiliated companies if this is necessary to provide you with our services, respond to your inquiries or for any of the purposes described in this policy.

We may also share your personal information with:

Transferring Your Information outside the UK & Europe

to data portability (moving some of your personal data elsewhere) in certain circumstances;

to object to your personal data being processed in certain circumstances; and

Where we are permitted to send you direct marketing communications, we may retain your contact information necessary for this purpose, for as long as you do not unsubscribe from receiving the same from us. If you opt out of marketing, we will retain your information to enable us to respect your wishes to not be contacted for marketing purposes.
